Introduction

The Nelson Mandela Children's Fund (NMCF) is seeking proposals from qualified consultants or organizations to conduct a qualitative impact study using the Most Significant Change (MSC) methodology or a similar qualitative approach. This study aims to gather and document qualitative stories of impact from NMCF's work over the past 30 years.

Objectives

The objectives of the study are to:

1. Gather qualitative stories of impact from the work of the Nelson Mandela Children's Fund over the last 30 years.
2. Produce the following outputs:
 - A full report, including an executive summary.
 - A short report (5 pages) summarizing the main findings.
 - A PowerPoint presentation of the research.

Scope of Work

The selected consultant/organization will:

- Conduct interviews and collect qualitative data from various stakeholders.
- Analyze the data using the MSC methodology or a similar qualitative approach.
- Prepare and present the findings in the specified formats.

- A detailed proposal outlining the approach and methodology.
- A budget breakdown.
- CVs of key personnel.
- Examples of previous relevant work.
